Age

The guideline applies only to adults. Any needs specific to children and young people have not been considered.

The guideline makes recommendations on minimising risk by offering alternatives to face-to-face services, for example using video or email consultations whenever possible, and by providing information online. Older people may find it difficult to access these services, which may increase feelings of isolation. The guideline attempts to mitigate this by advising several alternative communication methods that could be used, including phone consultations.

Older people may need support from families and carers if a face-to-face consultation is needed. The guideline recommendations allow for this by advising that patients should try to come alone if they can, but allowing for 1 person to accompany them if needed.

Socioeconomic factors

Some people may not have access to home delivery services for medicines, because of where they live (for example, rural areas). The recommendations state several alternative ways of delivering medicines, such as pharmacy deliveries, postal services, NHS Volunteer Responders or introducing drive-through pick-up points for medicines

Disability

People with some learning or developmental disabilities may need reasonable adjustments to care pathways, and support from additional resources such as local specialist learning disability teams. This forms part of standard care not specific to recommendations in the guideline, and implementation will vary according to local Have any potential equality issues been identified?
